February 25, 2019 (Special Meeting)

Meeting called to order at 7:06 PM by Mayor Jones

New Business

Ordinance 2019-05 – Re-zone Cole Stevenson property @ Hayes Street (7.59 acres) -

Mayor Jones read Ordinance 2019-05 in its entirety. Mike Bishop made a motion to suspend the rules and go to the second reading of Ordinance 2019-05 by title only. Martin Crain seconded the motion. Mayor Jones stated motion and second and then opened the motion to suspend the rules to council for discussion. Being no discussion, Mayor Jones called for a vote. Mayor Jones announced the motion to suspend the rules and go to the second reading of Ordinance 2019-05 by title only passed 6 Yays to 0 Nays.
