#### **New Business:**

1. Cooper & Mixon Architects and Civil Engineering:

Tim Cooper and John Mixon (Cooper & Mixon Architects) were present to speak to the council. Mixon updated the council with a new layout for construction of the Police Department portion of the proposed Municipal Building. The layout presented was a slightly modified version of the original

layout previously shown to the council for a building that included both the police department and city hall. This version includes a slight adjustment of some shared space in order to begin the project as a standalone police department building. This plan also makes it feasible for the city hall addition at a later date. Mayor Jones explained that he is looking at revenue sources which will help the city complete the police department portion of the municipal building in the near future. Jones added that this issue is ongoing and will be discussed further at the next meeting.

#### 2. MARCK Recycling (taking over residential trash pickup):

No one was present to speak on this item.

#### 3. Vector Disease Control Monthly Mosquito Report:

Mayor Jones advised the council that the monthly mosquito abatement report for July was on their desks. Jones asked the council if they had any questions about the report. None were asked.

# 4. Resolution 2024-15 – A Resolution by the City of Brookland to support the Craighead County ½ cent sales tax increase to build a new Craighead County Detention Center:

Craighead County Sheriff, Marty Boyd was present to speak to the council about the need to build a new detention center for Craighead County, Arkansas. Boyd explained that the current facility was approximately 35 years old and was built to house around 160 inmates, but currently has over 400 inmates housed there.

# 7. Craighead County Jail Contract:

Mayor Jones informed the council that the city needs to pay for the jail contract as presented. The monthly expense for housing inmates at the Craighead County Detention Center is based on average monthly inmate numbers for the years 2022-2023. The monthly amount of \$5,518.48 is due and is retroactive to January 1, 2024. This is a one-year contract.

# 8. Craighead County invoice for road extension work:

Mayor Jones stated that he invited County Judge Marvin Day to attend the meeting to answer questions about an invoice the city received for road work. Jones explained that Judge Day was not able to attend this month's meeting but could at a later date. Jones added that he would like to table this issue until later to give the council the opportunity to ask questions.

# 9. ARDOT Sidewalk Project #101143 Update:

Mayor Jones updated the council on this item. Jones stated that the city is still waiting for a final appraisal from Cavenaugh, in order to present the property owners with an amount for payment of the right of way.

#### 10. Dub & Jessie Thompson – abandoning Lynch St. ROW to retention pond:

Mayor Jones explained to the Thompson's that abandoning the ROW on Lynch Street is not as simple as a vote by the council. Jones added that the surveyor explained that the streets in Brookland are platted outside of property lines, therefore abandoning a right of way is not the correct option to solve this issue. Jones concluded by saying that the city is investigating the correct legal option to move forward with this request.

# 11. Mayor's Pay Scale Ordinance:

This item is tabled until the September regular monthly meeting.

#### 12. Parks Committee Update:

Mayor Jones updated the council on the progress of the two small city parks. Jones stated that concrete has been poured around the playground equipment and the trails will be the next step.
