1. Ordinance 2025-08 Franchise Bond Ordinance for Phase 1 of Municipal Building Project

Michael McBride, with Stephens Inc., underwriters for the bonds, came before the council to provide information regarding the bond sale for the proposed Municipal Building project. McBride covered the bond sale, annual interest rate, and approximate annual payment amount. Michael Moyers, attorney with Friday, Eldridge & Clark, LLC, was also present to provide an ordinance for issuance of the franchise tax bond and inform the council of requirements for the bond repayment. Moyers added that First Community Bank will act as trustee for the bond funds and explained the process for the city to requisition funds, which are issued directly by the bank, to pay for work on the Municipal Building project. Moyers added that the principal amount of the bond is \$1,215,000.

3. Condemnation Hearing for 127 Brady Lane:

Wade Shapp, Code Enforcement Officer for the City of Brookland, presented information on the property located @ 127 Brady Lane. Shapp went over the condition of the property and the home located on the premises. He provided current photos for the council to review. His recommendation is for the structure to be torn down and everything removed. Shapp provided time for the property owners to speak, however, no one was present at the meeting. Mayor Jones advised that, if the property owner does not contact the City of Brookland, within the allotted time frame, with plans to renovate the building and get the property back up to code, that the city will draft a resolution and vote at the next meeting to condemn the building.

2. Condemnation Hearing for 105 Brooks Street:

Wade Shapp, Code Enforcement Officer for the City of Brookland, presented information on the property located @ 105 Brooks Street. Shapp informed the council of the condition of the mobile homes located on the property and presented current photos. Shapp detailed the process and procedures he went through, in accordance with city ordinance, to begin the condemnation process. Shapp included that his recommendation for both mobile homes was to be demolished and hauled away, however, Shapp added that the property owner had recently begun demolition of one of the mobile homes and renovation/cleanup of the other. Sharon McCamey, property owner, came before the council to speak on behalf of her property. McCamey asked about what could be added or built on her property since adding another mobile home is not an option. Mayor Jones and Attorney Kevin Orr advised McCamey to go before the Brookland Planning Commission or see City Inspector, Shawn Dacus, for information on what is allowed on the property, according to its zoning code.
