
I, the undersigned, City Clerk of the City of Brookland, Arkansas (the "City"), hereby certify that the Certificate of the Craighead County Board of Election Commissioners certifying the vote at the election held in the City on June 8, 2021 on the questions of (a) approving or rejecting Ordinance No. 2021-03, which if approved, would amend Ordinance No. 2015-25 in order to authorize the net collections of the 2% sales and use tax levied within the City by Ordinance No. 2015-25 (the "Tax") to be used to pay and secure the repayment of bonds approved by the voters and issued by the City from time to time to finance and refinance capital improvements, has been filed in my office and presented to the Mayor and reflects that 74 votes were cast FOR the measure and 21 votes were cast AGAINST it; (b) issuing bonds in the maximum aggregate principal amount of \$3,070,000 for the purpose of financing all or a portion of the costs of refunding the City's Sales and Use Tax Bonds, Series 2016 and, in order to pay the bonds, the pledge of the Tax, has been filed in my office and presented to the Mayor and reflects that 73 votes were cast FOR the measure and 21 votes were cast AGAINST it; (c) issuing bonds in the maximum aggregate principal amount of \$4,370,000 for the purpose of financing all or a portion of the costs of park and recreational facilities and improvements, including particularly, without limitation, ball fields, any land acquisition therefor, and any furnishings, equipment, utility adjustments and lighting, street, parking, landscaping, signage and drainage improvements related thereto or in support thereof and, in order to pay the bonds, the pledge of the Tax, has been filed in my office and presented to the Mayor and reflects that 74 votes were cast FOR the measure and 21 votes were cast AGAINST it; (d) issuing bonds in the maximum aggregate principal amount of \$1,095,000 for the purpose of financing all or a portion of the costs of the acquisition and construction of a municipal building that will contain city offices and a police station, any land acquisition therefor, and any furnishings, equipment, utility adjustments and lighting, street, parking, landscaping, signage and drainage improvements related thereto or in support thereof and, in order to pay the bonds, the pledge of the Tax, has been filed in my office and presented to the Mayor and reflects that 72 votes were cast FOR the measure and 23 votes were cast AGAINST it; and (e) issuing bonds in the maximum aggregate principal amount of \$1,310,000 for the purpose of financing all or a portion of the costs of acquiring, constructing, and equipping extensions, betterments and improvements to the City's sewer facilities and, in order to pay the bonds, the pledge of the Tax, has been filed in my office and presented to the Mayor and reflects that 74 votes were cast FOR the measure and 21 votes were cast AGAINST it.

I certify that the copy of the printed ballot attached to the Certificate of the Craighead County Board of Election Commissioners is a true and correct copy of the ballot used at the Special Election, a copy of which has been filed in my office.

I further certify that the attached Proclamation is a true and compared copy of a Proclamation of the Mayor of the City, canvassing the returns of the election and declaring the results thereof, which is now of record in the office of the City Clerk.
