

ORDINANCE NO. 1987-3

AN ORDINANCE PROVIDING FOR PLACEMENT OF CERTAIN STOP SIGNS  
WITHIN THE TOWN LIMITS OF THE TOWN OF BROOKLAND, ARKANSAS

WHEREAS, it is necessary that certain stop signs be established within the Town of Brookland to provide for orderly traffic flow and protection of the citizenry of the Town of Brookland and surrounding areas,

NOW THEREFORE:

BE IT ORDAINED and enacted by the Town Council of the Town of Brookland, Arkansas, that:

Article I: Stop signs are hereby established and are to be placed at the following locations:
