OF AWARD OF CONTRACTS

WHEREAS, the Town of Brookland, Arkansas, has advertised for construction of Sewerage Improvements in the Town of Brookland, and

WHEREAS, the lowest bids have been received as follows:

WHEREAS, the Town Council, Brookland, Arkansas, has examined the bid tabulation and is of the opinion that the bid of Fred Heller, Inc., Hot Springs, Arkansas, is the lowest and best bid for Schedule I - Sewerage Collection System, and that the bid of Associated Constructors, Inc., Jackson, Mississippi, is the lowest and best bid for Schedule II - Sewerage Treatment Facilities.

NOW, THEREFORE, BE IT RESOLVED BY THE Town Council, Brookland, Arkansas.

That the bid of Fred Heller, Inc., Hot Springs, Arkansas, in the amount of \$753,497.61 for the construction of Schedule I - Sewerage Collection System, and the bid of Associated Constructors, Inc., Jackson, Mississippi in the amount of \$396,755.00 for the construction of Schedule II - Sewerage Treatment Facilities, is hereby accepted subject to the approval of the Environmental Protection Agency and Farmers Home Administration.

2. That Eugene T. Barnett, Mayor of the Town of Brookland, Arkansas, is hereby authorized to prepare and execute in behalf of the Town of Brookland, Arkansas, all necessary contracts and documents relating thereto, with each low bidder named in Section I hereinabove, which contracts shall be subject to approval of the Environmental Protection Agency and Farmers Home Administration, and all said low bidders shall be informed.
